**RESOLUTION OF THE GOVERNING BODY  
OF THE  
WALKER RIVER PAIUTE TRIBE  
RESOLUTION NO. WR-03-2020**

**BE IT RESOLVED BY THE TRIBAL COUNCIL OF THE WALKER RIVER PAIUTE TRIBE THAT:**

**WHEREAS**, the governing body of the Walker River Paiute Tribe is organized under the provisions of the Indian Reorganization Act of June 18, 1934 (48 Stat 984) as amended, to exercise certain rights of home rule and to be responsible for the promotion of the economic and social welfare of its members; and

**WHEREAS**, the Walker River Paiute Tribe is dedicated to protecting our Tribal sovereignty and to become self-sufficient to meet the needs of the Tribal membership; and

**WHEREAS**, the Tribes' desire to apply for the General Assistance Program is to ensure the development of the Environmental Department for the protection and management of our natural resources and the public health of the Tribal community; and


**WHEREAS**, the United States Environmental Protection Agency, Region IX, General Assistance Program accepts the proposed amount of \$190,000 for the fiscal year October 1, 2020 to September 30, 2021; and

**NOW THEREFORE BE IT RESOLVED**, that the Walker River Paiute Tribal Council approve to submit the grant application to the U.S. Environmental Protection Agency for the amount of \$190,000, and

**BE IT FINALLY RESOLVED** that the Walker River Paiute Tribal Council does authorize the Chairman, Vice-Chairman, or designated representative to enter into, negotiate, and execute an agreement with the Environmental Protection Agency Region 9 and that the authorities of the resolution remain in effect until such time that this grant is closed, renegotiated, or amended.

**CERTIFICATION**
