**RESOLUTION OF THE GOVERNING BODY
OF THE
WALKER RIVER PAIUTE TRIBE
RESOLUTION NO. WR-05-2020**

BE IT RESOLVED BY THE TRIBAL COUNCIL OF THE WALKER RIVER PAIUTE TRIBE THAT:

WHEREAS, the governing body of the Walker River Paiute Tribe is organized under the provisions of the Indian Reorganization Act of June 18, 1934 (48 Stat 984) as amended, to exercise certain rights of home rule and to be responsible for the promotion of the economic and social welfare of its members; and

WHEREAS, the Walker River Paiute Tribe's Environmental Department is committed to ensuring that reservation lands are clean of trash and that such is done in a manner that is in compliance with environmental laws and regulations, and

WHEREAS, the Tribe currently has a United States Environmental Protection Agency, CERCLA Section 128(a) Tribal Response Program grant that funds the Tribe's Brownsfield program that is for the protection of the Tribe's natural resources, and


WHEREAS, the Environmental Department wishes to extend the contract with a Cultural Resources Monitor (Contractor) that will complete the necessary documentation and coordinate with appropriate parties on site work, meetings, emails, conference calls, and any related work for the Brownsfield Program. The data gathered during the various scopes of work will be used for continued monitoring and preservation of cultural sites and resources. Such data collected may also be used to designate and register cultural and historic properties with the Nevada State Historic Preservation Office, and

NOW THEREFORE BE IT RESOLVED, that the Walker River Paiute Tribe wishes to enter into a contract for services with Misty Benner, Tribal Cultural Resources Monitor from October 1, 2020 to September 30, 2020 at a rate of \$30 per hour; the contract will not exceed \$ 2000, and

BE IT FINALLY RESOLVED that the Walker River Paiute Tribal Council does authorize the Chairman, Vice-Chairman, or designated representative to enter into, negotiate, and execute a Contract for Services and make any amendments thereto until this contract is closed, renegotiated, or amended.

CERTIFICATION
