RESOLUTION NO. WR-26-2020

BE IT RESOLVED BY THE TRIBAL COUNCIL OF THE WALKER RIVER PAIUTE TRIBE THAT:

WHEREAS, the governing body of the Walker River Paiute Tribe (“Tribe”) is organized under the provisions of the Indian Reorganization Act of June, 1934, as amended, to exercise certain rights of home rule and to be responsible for the promotion of the economic and social welfare of its members; and

WHEREAS, the Walker River Paiute Tribal Council is charged with the responsibility of establishing policy and acting to provide administrative guidelines; and

WHEREAS, the Walker River Tribal Council previously adopted Walker River Paiute Tribe Child Care Development Center Parent Handbook; and

WHEREAS, the Tribal Council has determined that it must now amend handbook and establish daily/weekly rates to support the overhead costs of the daycare program;

- Children between the ages of 6 months to 9 years of age
- **Rates;**
 - o Infants: 6 months-23 months \$25.00/per day; \$125/per week (full-time only)
 - o Toddlers: 2-4 years of age \$21.00/per day; #105/per week (full time only)
 - o School ages: 5 & up \$15.00/per day-\$75.00/per week (full time only)
 - o Part-time care: \$10.00/per day - \$50.00/per week (4 hours or less) (head start)
 - o Hourly drop-in rates: \$10.00/per hour (must give 24-hour notice)
 - o Multiple child discount: >2-3 kids = 20% discount on weekly rates only
- Initial Registration Fee:
 - o \$30.00/per child or \$40.00/per family (>2 or more)
- ITCN Subsidies to be capped at three (3).

NOW THEREFORE BE IT RESOLVED, that the Walker River Tribal Council hereby approves the following amendments to the Walker River Paiute Tribe Child Care Development Center Parent Handbook:

BE IT FINALLY RESOLVED, that these amendments shall be in effect March 01, 2020, and shall remain in effect until rescinded, amended, or replaced by the Tribal Council.
