There are a few things we would like to make you aware of:

In accordance with the **WALKER RIVER PAIUTE TRIBE LAW AND ORDER CODE – TITLE 1; Section 1-80-020** Who May be a Representative (b):

“All representatives, including Licensed Attorneys and Advocates, must complete at least two (2) hours of advocate training and successfully complete the Walker River Tribal Court Attorney/Representative Exam prior to practicing in the Tribal Court. Licensed attorneys may use proof of two (2) hours of state bar continuing education to satisfying the advocate training requirement...”

We would also like to advise you that we are recognizing adherents to and compliance with the **WALKER RIVER TRIBAL TAXATION CODE – TITLE 20; Section 7.7**: Business License Required:

“All persons who engage or carry on any trade, business, profession, or business activity of any sort on the Reservation shall obtain a business license as required. “

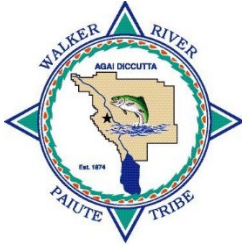

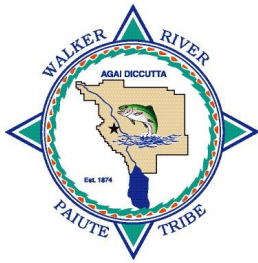
